**DIRECTIVE FOR DEFAULT JUDGMENTS TRIAL COURT PROCEEDINGS**

**BEFORE THE HONOURABLE ACTING JUDGE PIENAAR FOR**

**18 SEPTEMBER 2023 TO 29 SEPTEMBER 2023**

1. All matters will be heard in open Court at 9:30. Introductions shall take place in Chambers in the office of the secretary at Room 6.13 at 9:15. The court in which the matter will be heard will be reflected on the day roll circulated on a daily basis.
2. Legal representatives should ensure that all relevant documents are uploaded to Caselines. If all documents are not filed, the matter will be removed from the roll.
3. Counsel for each matter is required to furnish the court with one hard copy of the draft order. Draft Orders must correctly depict the Judge's details (PIENAAR AJ), date on which the matter was heard, in which court room and the name and contact details of the Counsel (if any) and instructing attorney at the end of the draft order.

4. Matters that have become settled: A separate profile called Settlement bundle must be created containing the following:
  - 4.1 Offer and acceptance
  - 4.2 Confirmation letter in respect of draft order
  - 4.3 Draft Order
5. In the event of a removal or postponement, the Judge's Registrar must be informed timeously, in order to inform the Judge not to read the papers.
6. Heads of Argument must be uploaded under a separate section called- Heads of Argument by 14:00 on the day before the set down date. Matters on the roll on 20 September 2023 - Heads of Argument to be uploaded by no later than 14:00 on 19 September 2023.
7. Matters may be called in order of seniority (including matters that stood down) after postponements, settlements and removals.

9. Please ensure that there is compliance with the Judge President's Practice Directives.
