- 4. The draft order for the DJ trial as a separate heading must be uploaded in PDF and Word. TWO hard copies of the draft order must be available at the hearing of the matter. Please make sure there are no typographical errors on the drafts before they are handed up in Court.
- 5. Matters will be heard according to the seniority of the counsel/attorney appearing in the matter i.e. the practitioner who will be arguing the matter.
- 6. Matters that have become settled: A separate profile called SETTLEMENT BUNDLE must be created containing the following: Offer and acceptance, Draft Order, Confirmation letter in respect of draft order This is to ensure that another Court is not burdened with a matter that has already been read. Matters will not be stood down for settlement.
