3. **Draft Orders** must correctly indicate the Judge's name (i.e. LENYAI J), date on which the matter was heard, in which Court and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney.
4. During the open court hearing the following shall be adhered to:

- 4.1. Introductions shall take place in court and not in chambers.
- 4.2. Matters will be called in accordance with the order of seniority.
- 4.3. If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalize counsel's roll as expeditiously as possible and for counsel to be excused from the court.
- 4.4. No matters will be struck prior to 11:30 to allow attendance in the Senior Judge's court.
