3. Please also note that the master bundle must be properly **indexed and paginated** and uploaded onto CaseLines. If not, it will result in your matter be struck from the roll. Each document should be identified in the master bundle, including annexures, which must also be identified. This must be done before **FRIDAY 27 AUGUST 2021 at 10:00.**
