NOTICE WITH REGARD TO SETTLEMENT ROLL BEFORE JUDGE MILLAR (AJ) - 28 JANUARY 2021

Matters will be dealt with on paper and counsel will be contacted in the event that the Judge requires to be addressed on a virtual platform.

- 1. You are requested to file a <u>Memorandum of Settlement</u> with regard to the following:
 - 1.1 Merits:
 - 1.2 Quantum.
 - 1.3 Contingency fee agreement (whether applicable and where to find it).
- 2. With regard to the quantum a full explanation and motivation should be given with reference to each of the components and how that amount is computed.
- 3. It should be borne in mind that the court is not bound to any settlement as this kind of litigation concerns the handling of public funds. It may therefore be necessary to also appear and motivate the settlement.
- 4. The matters will be adjudicated on paper only as submitted to Ms. Hefer referred to in par 7 below, unless there is a request for an oral hearing (to be set out in the memorandum referred to above) or if a party is called upon to appear. Counsel is therefore requested to be available for an oral hearing when it may be necessary.
- 5. A copy of a letter by the RAF confirming the settlement should be filed.
- 6. A proper Draft Order, <u>prepared in Word format, should also be filed.</u>
- 7. The memorandum, confirmation letter and Draft Order must be uploaded to CaseLines by 16:00 on 27 January 2021.
- 8. Counsel must be ready to join the meeting on 28 January 2021 which will be scheduled for 11:30, if required to do so by the Judge.
- 9. It is the duty of the plaintiff's attorney to ensure that the matter concerned is fully uploaded onto case lines and that the Judge and his secretary (invite to JHefer@judiciary.org.za) will have access to it if it becomes necessary. Kindly refer to the attached settlement roll 2 on which it is indicated with a question mark which matters the secretary does not have access to.

A failure to comply with this notice may result in the matter to be removed from the roll.
