DIRECTIVE FOR THE TRIAL DEFAULT JUDGMENTS ROLL BEFORE SETHUSHA-SHONGWE AJ – 15, 16 & 17 MAY 2023

1. Kindly find the attached Trial Defaults Judgments roll for matters to be dealt with by Sethusha-Shongwe AJ on Monday, Tuesday and Wednesday.
2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4B**. Introductions will be conducted at **Palace of Justice chamber 176, 09h45**.
3. In order for the court to consider the matter, parties should ensure that the all relevant documents, **Practice Note, Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**. 6. The Court roll will be called in **Numerical Order**, Counsel/Practitioners if appearing before a Senior Judge should inform the Judges Registrar for a stand down.
7. The decorum of the court is to be maintained at all times.
8. Notices of removals should be uploaded onto Caselines.
