**DIRECTIVE FOR THE JUDICIAL CASE MANAGEMENT MEETING ROLL BEFORE

1. Kindly find the attached Judicial Case Management meeting roll for matters to be dealt with by Sethusha-Shongwe AJ on Monday, Wednesday and Friday.
2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4B**. Introductions will be conducted at **Palace of Justice chamber 176, 09h45**.
3. In order for the court to consider the matter, parties should ensure that the all relevant documents, **Practice Note, Notice of Set down** and **FORM 10** are **uploaded onto Caselines**. The **FORM 10** should set out the **date of hearing, Roll Number, Judge's name** (i.e Acting Judge Sethusha-Shongwe) and the manner in which the **matter will be heard** (i.e Court 4B), and relevant information should be clearly stipulated.

5. Kindly take further note that all the relevant documents should be **uploaded onto Caselines a day before the trial date at 16h00**. Documents uploaded outside
