DIRECTIVE FOR THE TRIAL DEFAULT JUDGMENTS ROLL BEFORE SETHUSHA-SHONGWE AJ – 18 & 19 MAY 2023

1. Kindly find the attached Trial Defaults Judgments roll for matters to be dealt with by Sethusha-Shongwe AJ on Thursday and Friday.
2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4B**. Introductions will be conducted at **Palace of Justice chamber 176, 09h45**.
3. In order for the court to consider the matter, parties should ensure that the all relevant documents, **Practice Note, Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**. The Draft Court Order should set out the **date of hearing, Roll Number, Judge's name** (i.e Acting Judge Sethusha-Shongwe) and the manner in which the **matter will be heard** (i.e Court 4B), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft.
4. Attorneys for the Applicant should also ensure that a **compliance declaration** is **uploaded onto Caselines**, failing which the matter will be **removed from the roll**.

5. Kindly take further note that all the relevant documents should be **uploaded onto Caselines a day before the trial date at 16h00**. Documents uploaded outside of the stipulated times will not be considered and will result in the **matter being removed from the roll**.
6. The Court roll will be called in **Order of Seniority**, Counsel/Practitioners if appearing before a Senior Judge should inform the Judges Registrar for a stand down.
7. The decorum of the court is to be maintained at all times.
8. Notices of removals should be uploaded onto Caselines.
