BEFORE MALINDI J**

1. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams. The invitation will be sent on the day of the hearing.
2. Parties should ensure that all documents including draft orders and practice notes are filed on Caselines. Practice notes should set out, amongst others, legal practitioners' contact details (names, email addresses and contact numbers).
