BEFORE COLLIS J

1. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of Microsoft Teams.
2. Parties appearing on Monday, 1 August 2022, should ensure that all are filed on Caselines by no later than close of business on Thursday, 28 July 2022.
3. Parties appearing on Tuesday, 2 August 2022, should ensure that all documents are filed on Caselines by no later than close of business on Friday, 29 July 2022.
4. Parties appearing on Wednesday, 3 August 2022, should ensure that all documents are filed on Caselines by no later than close of business on Monday, 1 August 2022.

5. Parties appearing on Thursday, 4 August 2022, should ensure that all documents are filed on Caselines by no later than close of business on Tuesday, 2 August 2022.
6. Parties appearing on Friday, 5 August 2022, should ensure that all documents are filed on Caselines by no later than close of business on Wednesday, 3 August 2022.
