In certain matters the presence of the plaintiff is required despite the matter not involving minor children.)

 Papers uploaded after 15h00 on Friday, 28 June 2024 will not be considered.
- 4. One hard copy of each draft order which is to be made an order of court must be handed up in court. Each draft order must indicate the Judge's name, the date on which the matter was heard, the court in which the matter was heard, the name and contact details of counsel appearing and the name and particulars of their instructing attorney.
