- The proceedings will be conducted in OPEN COURT (courtrooms still to be allocated) starting at 10:00am.
- IN COURT ONLINE MATTERS THAT WERE NOT DISPLAYING ON CASE
   LINES BY THE TIME THE ROLL CLOSED, the Applicant must ensure that
   the matters are reflecting on CaseLines by <u>Friday 18 August 2023 at 16h00</u>,
