- The Court roll has been received and the matters to be adjudicated by Judge Khumalo (Ms) appears below. The roll and directive of Judge Holland-Muter can be obtained from his Judge's Registrar.
- 2. Kindly be advised that the general Family Court Directives are to be STRICTLY complied with.
- 3. There will be no open court appearances, the matters will be heard virtually via MS Teams. There will be a separate link daily and it will be made available to the relevant parties as well as posted as 'wide access note' on Caseline, by the Judge's Registrar.
- 4. Litigants must be robed when appearing on the virtual platform, mute themselves when they are not arguing but remain visible at all times when their matter is being heard. The decorum of the court is to be maintained at all times.
- 5. The hearings will be in accordance with allocations as set out on the roll attached below. Legal practitioners, and their clients as applicable, are required to log on to the MS Teams at least 30min before the commencement thereof in order to attend to possible technical difficulties.



- 6. Matters must be accessible on Caseline in order to be adjudicated. The onus lies on Litigants to ensure this.
- 7. A Practice Note and Joint Practise Note, when opposed, comprehensively indicating the issues to be decided upon in the matter should have been filed and accessible on Caseline. Non-Compliance will result in the matter being removed from the roll, due to papers not being in order, without the matter being called.
- 8. Draft Orders, both in MS Word and PDF formats, containing the relieve sought must be both filed and emailed to the Judge's Registrar. Draft Order must indicate the correct date and Judge's name as follows: THE HONOURABLE MADAM JUSTICE KHUMALO. Representative full details and contract particulars must appear at the bottom thereof. In the event that Draft Orders need to be amended, as per the Judge's instruction, litigant are required to BOTH file and email such the same day. The matter will not be considered disposed of otherwise.
- 9. No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge Khumalo (Ms). Non-Compliance will result in the matter being removed from the roll, due to papers not being in order, without the matter being called.

URGENT COURT FAMILY MATTERS

- 10. Matters to be launched as urgent applications must be done so in accordance with Consolidated Practice Directive 1 of 2023 with effect 01 October 2023. Distinction whether matters are to be heard in the Urgent Court or Family Court are defined therein.
- 11. In the event that a urgent matter is enrolled in the Family Court. The Judge's Registrar must be contacted immediately and the matter will then be allocated further. An allocation does NOT mean that the matter is considered sufficiently urgent to hear on the merits. Submissions will need to be made regarding the grounds of urgency before the merits are heard.
- 12. An outcome roll will be circulated and be available at the relevant Registrar's Office for litigants' benefit.
