**FAMILY COURT: 27-31 MAY 2024**  
**BEFORE THE HONOURABLE JUSTICE MBONGWE J**

**DIRECTIVE**

1. All family court matters before the honourable Justice Mbongwe J will be heard in open court at 10h00 unless otherwise directed. Details of the court allocated should be checked on the Day Roll.
2. Parties must ensure that their matter is fully uploaded on Caselines by Friday, 24 May 2024 at 13:00. Any papers filed after the 13:00 deadline will not be considered.
3. In Court Online matters whose documents did not display at the close of the roll, all documents must be fully uploaded on Caselines by Friday, 24 May 2024 13:00, failing which the matter will be removed from the roll.
4. In respect of divorces:
  - 4.1 There must be appearance in person by either the Plaintiff or Defendant where minor children are involved;
  - 4.2 In unopposed divorce matters where there are no minor children involved, plaintiffs are not required to appear if they have uploaded an affidavit containing their evidence. If an affidavit is not uploaded, the plaintiff must appear in court.

5. The allocation of matters is as follows:
  - Monday, 27 May 2024: Divorces
  - Tuesday, 28 May 2024: Other Family Matters
  - Wednesday: 29 May 2024 Rule 43
  - Thursday, 30 May 2024: Rule 43
  
6. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders and settlement agreements, where applicable, must correctly indicate the Judge's particulars, date, court, and names and contact details of both Counsel and their instructing attorney.
  
7. The general Family Court directives set out in the Consolidated Directive 1 of 2024 must be complied with. Any matter that is non-compliant may be removed from the roll.
  
8. If the parties decide for any reason that the matter shall not proceed, same must immediately be communicated to the Judge's Secretary.
  
9. Introductions will be done in court.
