3. Plaintiffs in unopposed divorce matters are not required to appear in person if they have uploaded an affidavit containing their evidence. If an affidavit is not uploaded, the plaintiff must appear in court.
4. Parties must ensure that a case profile is created for their matter on Caselines and all relevant documents must be uploaded before end of business on the **08 March 2024**.
5. If a **draft order** is to be made an order of court, **one hard copy** must be brought to be handed up in court. **Draft Orders and settlement agreements**, if applicable, must correctly indicate the Judge's name (i.e. Kok AJ), date on which the matter was heard, in which court and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney.
