- 4. Parties must ensure that a case profile is created for their matter on Caselines and all relevant documents must be uploaded thereon before 12h00 on Friday, 17 May 2024. No further papers will be considered after 12h00 on Friday the 17 May 2024.
- 5. If a **draft order** is to be made an order of court, **one hard copy** must be brought to be handed up in court. **Draft Orders and settlement agreements,** if applicable, must correctly indicate the Judge's name (i.e. RETIEF J), date on which the matter was heard, in which court and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney.
- 6. Introductions to the Judge shall take place at **08H40** in office 176 on the first floor at the Palace of Justice.
