Judge's Directives

- 1. Matters will be heard in open court. Courtroom allocations are published by the office of the DJP. Court begins at 10:00.
- 2. Parties must ensure that their matters are <u>accessible on Caselines</u> (including matters that were initiated on CourtOnline). Should a matter <u>not be accessible</u> <u>on Caselines by Monday, 22 January 2024, 08:30,</u> it will be removed from the roll.
- 3. Any affidavit evidence that the parties seek to rely upon shall be uploaded on Caselines by no later than <u>Friday 19 January 2024 at 17:00</u>. Matters run the risk of being removed should affidavits not be uploaded by the time stipulated herein.
- 4. Heads of Argument must be uploaded on Caselines by no later than <u>Monday 22 January 2023 at 09:00</u>. Matters run the risk of being removed should Heads of Argument not be uploaded by the time stipulated herein.
- Introductions will be in chambers at 09:45.
- 6. Draft orders must clearly reflect the surname of the presiding judge (KHOZA AJ), date, the name of counsel and the attorney(s), and their respective telephone numbers and email addresses. It is essential to have the email addresses included. The draft order should be in a format ready to be made an order of court.

 If the phrase 'further and/or alternative relief' appears in your draft order, it must be deleted. Draft orders must be signature ready.
- 7. Kindly upload the draft order in MS Word format onto Caselines and bring one hard copy of the draft order to court.
- 8. Please contact the Judge's secretary should there be any removals /withdrawals/settlements as soon as possible. These will be dealt with first on the day of hearing.
