Default Judgment Court Directive

Draft orders must be uploaded onto CaseLines in MS Word format, must clearly reflect the surname of the presiding judge (CORNELISSEN AJ), the date, the name(s) of the counsel and attorney(s), their respective telephone / cellular phone numbers and email addresses. All draft orders must be signature ready and a hard copy must be brought to court.
