RE : NOTICE TO THE LEGAL PROFESSION AND ALL

STAKEHOLDERS IN THE HIGH COURT, JOHANNESBURG - LEAD TIMES AND CIVIL ROLL

CONGESTION

- Attached hereto is a bulletin of the lead times for cases to be allocated dates. In the future such a bulletin shall be published monthly.
- 2. The basic policy premise in this court is to provide the litigating public with an effective litigation service. The bulletin deals with one aspect of that aspiration.

- 3. The lead times for most rolls are within reasonable times. The lead times for the civil trials are not. At some three years lead time for a trial date is being treated as a crisis. Regrettably no obvious solution presents itself as a quick remedy. The reason for the long delays is straightforward the volume of cases set down cannot be heard sooner by the number of judges or acting judges that can realistically be mustered.
- 4. A meeting with the leadership of the profession will soon be called for to address the issues implicated in such long delays.
- 5. There are a few obvious chronic circumstances which contribute materially to the length of the queue for a set down date. I mention them:
 - 5.1. First, matters that are not genuinely ripe to be set down are given slots where the realistic use of court time is not envisaged. Such matters steal slots from deserving cases and push out the dates of availability.
 - 5.2. Second, appropriate genuine efforts to settle early are not made. Appropriate efforts include mediation but are not confined only to that methodology. This habit is blot on the profession and among the reasons often cited to accuse practitioners of running up fees.
 - 5.3. Third, exaggerated estimates of the duration of a case are made which then unfairly eats up available slots. A variant of this is the failure to cut down the case to what is truly in dispute, saving valuable court time for other litigants.

6. Plainly, court time is a scare and valuable resource which we must ration fairly.

Adaptations shall be made from time to time to the system of rostering matters to

secure the most efficient method of hearings and locate the case on the most

appropriate roll to achieve that outcome.

7. Please be circumspect in the manner in which you seek court time.
