**Directive for the Opposed Motion Court before GRAVES AJ**

1. All matters will proceed in open court.

2. The parties are directed to create bundles on Caselines by no later than 12h00 on the 22<sup>nd</sup> July 2024, failing which the matter may be removed from the roll.
3. Notwithstanding para 2 above, all matters where bundles have NOT been created will be called **at 10:00 on Monday 29 July 2024** for management. Parties must Not assume that this will entitle the matter to be allocated for hearing.
4. A practice note must accompany all applications. The Applicant's failure to file a practice note, will result in a matter being removed.
5. All matters that do not comply with the Joint Practice Manual will be removed from the roll unless counsel can motivate why such non-compliance should be condoned.
6. Where matters are settled, or are to be removed on the day of the hearing, counsel shall advise the Judge's registrar as soon as possible of such removal.
7. Matters involving unrepresented litigants, will be called at 10:00 on Monday 29 July 2024, for further management as required.
8. Counsel are required to hand up two hard copies of the draft orders prayed for.
