- 1. Roll call for allocation will be conducted in OPEN COURT 4F at 10h:00 am;**
- 2. Draft orders must correctly depict the Judge's surname (i.e Strijdom AJ), date on which the matter was heard, in which court room and at the end of the draft indicate the name and contact details of the counsel (if any) and instructing attorney;**
- 3. Counsel must print out one copy of the Draft order;**
- 4. Stamped and signed draft orders will be uploaded on case lines on the same day unless the court proceedings were delayed and as a result the court adjourned late;**
- 5. For any reserved Judgment, parties will be informed through email when same has been uploaded on case lines;**

6. A Joint Practice Note, stating the nature of the application, the date, number on the roll and contact details (including email address) of the legal practitioner, must be uploaded on Case lines.
7. During the proceedings the following shall strictly be adhere to:
 - 7.1 introductions shall take place in chambers, practitioners must report to office number: 2.7 on second floor at 09h:45 am;
 - 7.2 Matters will be called in numerical order as per roll during allocation but preference will be given to Senior Counsel.
8. Notices of removals which occur before the 29th of August 2022 must be emailed to zmsimanga@judiciary.org.za before or on the 26th of August 2022. In which case, Counsel will automatically be excused from Court.
