2. Kindly take note that roll call will be held on **Monday, 25 July 2022 at 10h00 in Court 4C**.
3. Please inform writer hereof as soon as possible of any settlements, withdrawals and removals via email at: ChMsimango@judiciary.org.za and also ensure that a notice to that effect is filed/uploaded onto Caselines.
4. Kindly take note that roll call will be held on **Monday, 25 July 2022 at 10h00 in Court 4C**.
5. A sub-roll indicating exactly when and what time your matter is heard will be sent out in due course.
6. Practitioners are to file a Joint Practice Note in which they are to indicate:
 - whether a hearing is necessary or whether the matter may be decided on the papers
 - the agreed duration of the matter where a hearing is required
 - the agreed outline of the disputes
7. Parties should ensure compliance with relevant directives pertaining to delivery and uploading of both parties' Heads of Argument or court orders obtained through an Application to compel.

8. In the event that the heads of argument are incomplete or have not been timeously received, or where no practice note has been filed timeously, the matter will be removed from the roll. No practitioner may/will be able to file any further documents once bundles are frozen.
