

DIRECTIVE

OPPOSED MOTIONS BEFORE JUDGE MOLEFE

- 1. Judge Molefe has been provided with her roll and therefore points 4, 5 and 6 below are of importance.
- 2. Inform writer hereof as soon as possible of any settlements and withdrawals.
- 3. A sub-roll indicating exactly when and what time your matter is heard will be sent out in due course.
- 4. Practitioners are to note that the week is a short one with only 4 days available for hearing, thus practitioners will be kept strictly to the duration of matters stated in their practice notes.
- 5. Practitioners are to note that as the week of 03 May 2022 has a public holiday, practitioners are to provide Judge Molefe's secretary (Chimsmango@judiciary.org.za) with a JOINT practice note by no later than 28 APRIL 2022 at 12h00 in which they are to indicate:
 - whether a hearing is necessary or whether the matter may be decided on the papers
 - the agreed duration of the matter where a hearing is required
 - the agreed outline of the disputes
- 6. In the event that the heads of argument are incomplete or have not been timeously received, or where no practice note has been filed timeously, the matter will be removed from the roll. No practitioner may/will be able to file any further documents once Judge Molefe is in possession of the roll and if any documents are filed without her express permission, the matter will automatically be removed from the roll.
