THE HONOURABLE ACTING JUDGE STRYDOM: MONDAY THE 24TH OF JULY 2023 DIRECTIVE

Please find attached the allocated roll for the week of 24 to 28 JULY 2023

Directive:

- 1. Please ensure that all the relevant documents are uploaded onto CaseLines by Monday 10 July 2023 at 12h00.
- 2. There shall be <u>no roll call</u> and the parties are to appear on the time allocated on the allocated roll.
- 3. Applications will be heard in <u>open court</u>. The court in which the matters will be heard will be reflected on the day roll circulated on a daily basis. If for any unforeseen reason a matter is to be heard on electronic platform, the practitioners will be informed in writing as soon as reasonably possible.

- 4. Should any Counsel wish for the matter to be heard on Microsoft Teams, such requests will be accommodated as far as possible, provided that all Counsel involved in that motion agree thereto, and the agreement is noted in the joint practice note referred to in paragraph 6 below.
- 5. If a party intends to seek a postponement of an application, and the other party does not consent to such a postponement, a substantive application needs to be served and filed timeously. A complete set of exchanged documents of the postponement application should be uploaded onto Case Lines by no later than Thursday 20 July 2023 at 12h00.
- 6. For the purpose of communicating to the parties, a **Joint Practice**Note (in the matters where both parties are represented and participating in the proceedings) should be uploaded onto Case Lines (marked bundle 0000 Joint Practice Note) by no later than Friday 14 July 2023 at 12h00 reflecting the following information:
- a. Particulars and contact details (email, cell phone and landline numbers) of the legal practitioners (both Legal Practitioners (Advocates) and Legal Practitioners (Attorney);
- b. Nature of the relief sought / the main issues for consideration.
- c. A brief summary of the factual as well as legal issues involved.
- d. An indication of the estimated time required to finalise the argument.
- e. <u>A clear indication of which portion(s) on Case Lines are to be read</u> and which not.
- 7. Please insert the date, and the Judge's name (Strydom AJ), and the Court in which the matter is heard on all proposed court orders.

- 8. All court orders must be uploaded onto Case Lines in Word format and copies should be available for handing up in duplicate for signature by the Judge.
- 9. Practitioners are urged, prior to moving an application, to consider the widely shared notes function, as annotated by the Judge on Case Lines which might be placed on the eve of the hearing.
