1. Kindly note that the matters referred to below have been allocated to Kilmartin AJ.
2. The mode of hearing and dates on which the matters will be heard will be communicated early next week after the respective joint practice notes have been considered. Matters where litigants will appear in person will be heard in open court.
3. uploaded) must be delivered to Heidi Kahlert at Room 207, Circle Chambers, 570 Fehrson Street, Brooklyn, Pretoria **by close of business on Friday, 3 March 2023.**

5. Please note:

5.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, consideration of the compliance with the relevant directives pertaining to opposed motions will apply.

5.2. Parties should email proposed draft orders in Word format to [TsMpuru@judiciary.org.za](mailto:TsMpuru@judiciary.org.za) at least the day before a particular matter will be heard. Such draft orders must also be uploaded on CaseLines. Draft orders should indicate when the matter will be heard, the Judge's name, and the manner in which the matter will be heard (i.e. open court or on a virtual platform), and at the end of the draft order the names and details of all counsel/practitioners and of their instructing attorneys must be included.
