**DIRECTIVE: OPPOSED MOTIONS BEFORE ACTING JUDGE VAN DER MERWE  
FOR 22-24 MAY 2024:**

1. There will be no roll call. All matters will be heard in open court and called on the date and at the time indicated on the roll below. Counsel need only appear on the date and time allocated. Parties should take note that the date and time of hearing may be amended, if necessary.
2. Matters that have become settled, removed or postponed by agreement must be communicated by email to Ms P Tolla at [Ptolla@judiciary.org.za](mailto:Ptolla@judiciary.org.za) without delay. These matters may be called on **Wednesday , 22 May 2024 at 10h00**.
3. Parties must ensure that all documents, including joint practice notes, outstanding heads of argument, list of authorities etc., must be uploaded onto Caselines by no later than **close of business on Wednesday, 15 May 2024**.
4. Where no practice notes or heads of argument have been filed on behalf of any party, the other party should upload a supplementary practice note onto Caselines, referring to:
  - 5.1 The notice of set down;
  - 5.2 Service of the notice of set down;
  - 5.3 Service of the practice note, heads of argument etc.

5. Parties should ensure that proposed draft orders are uploaded onto Caselines and emailed in MS Word format to Ms P Tolla at [PTolla@judiciary.org.za](mailto:PTolla@judiciary.org.za) by no later than **close of business on Wednesday, 15 May 2024**. Draft orders should indicate the hearing of the matter, the Judge's name and the manner in which the matter will be heard (i.e. open court) and at the end of the draft order the names and details of all counsel/practitioners and of their instructing attorneys must be included. Parties should hand up 2 hard copies of the proposed draft order in court at the hearing of the matter.
6. The parties are referred to paragraph 7.1 to 7.6 of the Consolidated Practice Directive 1 of 2024.
7. Failure to comply with the provisions of the Consolidated Practice Directive 1 of 2024, will result in your matter being struck from the roll.
8. By no later than **12h00 Wednesday, 15 May 2024**, the parties in all matters should deliver hard copies of practice notes, joint practice notes and heads of argument marked for the attention of the presiding judge, to:
