**OPPOSED MOTIONS DIRECTIVE: 11 - 15 2021 BEFORE SEKHULA AJ**

1. Kindly take note that all matters will be dealt with by way of videoconferencing through Microsoft Teams, however, under exceptional circumstances the Judge is amenable to hear matters in open court.

2. Parties should ensure that heads of argument and practice notes are filed on Caselines. Practice notes should set out, amongst others, legal practitioners' contact details (names, email addresses and contact numbers).
3. Parties should ensure compliance with relevant directives pertaining to delivery and uploading of both parties' Heads of Argument or court orders obtained through an Application to Compel.
4. Kindly take further note that uploading of documents on Caselines outside of stipulated times and without condonation will result in the matter being struck off the roll and costs *de bonis propriis* may be ordered against the errant practitioner.
5. Parties should e-mail proposed draft orders in word format to Awelani Thangavhuelelo at [AThangavhuelelo@judiciary.org.za](mailto:AThangavhuelelo@judiciary.org.za) and cc [athangavhuelelo.judiciary@gmail.com](mailto:athangavhuelelo.judiciary@gmail.com) on the day that a particular matter is heard. Draft orders should indicate when the matter will be heard, Judge's name (i.e Acting Judge Sekhula) and the manner in which the matter will be heard (i.e Microsoft Teams), Court name/number (i.e Court 2B) and the end of the draft order should indicate the name and details of Counsel/Practitioner and those of the instructing attorney.
6. Counsel/Practitioners appearing on virtual proceedings should be robed. Counsel/Practitioners not addressing the court should mute themselves but remain visible at all times when their matter is being heard. The decorum of the court is to be maintained at all times.
