DIRECTIVE

OPPOSED MOTION COURT BEFORE JUDGE NEUKIRCHER

WEEK 4 – 8 to 12 August 2022

1. Kindly find hereunder the opposed motion court roll before Judge Neukircher.
2. Judge Neukircher has been provided with her roll and therefore points 4, 5 and 6 below are of importance.
3. Inform writer hereof as soon as possible of any settlements and withdrawals.
4. Practitioners are to provide Judge Neukircher's secretary (J.Nair@judiciary.org.za) with a JOINT practice note by no later than 29 July 2022 in which they are to indicate:
 - Hearings will take place in court **UNLESS** the parties specifically agree that a virtual hearing is agreed to **OR** the matter may be decided on the papers
 - the agreed duration of the matter where a hearing is required
 - the agreed outline of the disputes
5. In the event that the heads of argument are incomplete or have not been timeously received, or where no practice note has been filed timeously, the matter will be removed from the roll. No practitioner may/will be able to file any further documents once Judge Neukircher is in possession of the roll and if any documents are filed without her express permission, the matter will automatically be removed from the roll.
6. Practitioners are to note that the bundles have already been frozen. If the link is not received at this stage, or not populated, the matter will not be heard. The only document that will be permitted to be uploaded (with permission of the Judge), is the Joint Practice Note.
7. Kindly note that after the joint practice note has been received a further allocated roll indicating the time and date of hearing will be sent to the parties.
