The unopposed motions will be done as follows:

1. Please be advised that it is not protocol to contact a Judge personally, either by way of an email or a phone call.
2. All matters relating to the **UNOPPOSED MOTIONS** for **TUESDAY 6 JULY 2021 AND THURSDAY 8 JULY 2021** will be heard in **OPEN COURT**.
3. Further please note that your practice note must be in accordance with the Practice Directives issued by the Judge President. If not, please rectify and upload it onto CaseLines well in time. **IF THIS IS NOT DONE YOUR MATTER WILL BE STRUCK FROM THE ROLL.**
4. Please also note that the master bundle must be properly indexed and paginated and uploaded onto CaseLines. If not, it will result in your matter be struck from the roll. Each document must be identified in the master bundle, including annexures, which must also be identified. If this was not done before 12h00 Thursday 1 July 2021 the matter will be struck from the roll.
5. All protocols relating to the National State of Disaster will be followed, such as wearing a mask, social distancing and sanitizing. Only ten (10) attorneys and/or advocates will be allowed to be in Court at any given time. All doors will be open at all times and the

tables/desks will be regularly sanitized.
