DIRECTIVE FOR UNOPPOSED MOTIONS BEFORE JUDGE POTTERILL ON 9 NOVEMBER 2021

- 1. Attached to this directive is the unopposed motion roll for 9 November 2021.
- 2. The unopposed motion roli of <u>Tuesday 9 November 2021</u> will be called virtually via Microsoft Teams on 9 November 2021 and the hearing will begin strictly <u>at 09</u>:00.
- 3. All counsel are required to appear in all the applications.
- 4. All counsel should be robed for the appearance.
