UNOPPOSED MOTION COURT BEFORE JUDGE NEUKIRCHER

21 OCTOBER 2021

1. Attached hereunder is the unopposed motion roll for **Thursday, 21 October 2021** before Judge Neukircher.
2. Ensure that NNair@judiciary.org.za is invited to your matter.
3. **ALL** parties need to appear in the matters set down for Thursday save for matters 65, 68, 70, 73, 77, 81, 87, 92, 94- in these matters draft orders in word format are to be emailed to NNair@judiciary.org.za by no later than Tuesday 20 October at 12h00. Kindly note that, in the event of an in person appearance, in any of these matters, you will be required to appear and make submissions. Orders will only be issued upon conclusion of the roll.
4. In the subject of the email indicate your roll number and where necessary attach the settlement agreement as well.
5. Counsel and attorneys are directed to check Caselines. Where possible the judge has left a "widely shared note" to indicate problems in the matter.
6. Where there are problems to be addressed, counsel is expected to log in to a Microsoft Teams hearing which will commence at 10h00 on the day in question. **NO SUBMISSIONS ON CASELINES ARE PERMITTED. NO FURTHER DOCUMENTS MAY BE UPLOADED without the judge's express permission.**

7. If any new papers are uploaded to Caselines without express permission from Judge Neukircher the matter will be struck off the roll.
8. If anyone responds to a note on Caselines, the matter will be removed from the roll – submissions are to be made (if any) on Thursday 21 October on the MS Teams platform and not via a note on Caselines.
9. Where counsel are required to make submissions they are to be logged on by no later than 09h50 on 21 October 2021. The court will commence at 10h00. Cameras are to remain off and microphones muted unless you are called upon to make submissions. Please ensure that there is no window behind you as the light is disturbing on camera. Ensure your environment is conducive to conduct a hearing and that you are appropriately robed.
10. If, once submissions are made and the judge is satisfied that an order should be granted that draft order is to be emailed to the judge's secretary immediately. Failure to do so will cause the matter to be removed from the roll.
