(Practice note to be uploaded on caselines)
- 2. Where difficulty is experienced in uploading to Caselines, Ms Mabona may be contacted to assist.

- 3. All matters which are in order will be disposed of on paper unless practitioners wish to make oral submissions. If this is the case, that must be clearly stated in the practice note or in a supplementary practice note which must be delivered together with the proposed draft order.
