1. Kindly find the attached Unopposed Applications roll for matters to be dealt with by **Acting Judge Meersingh on the 03 October 2022**.
2. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams. The hearing will commence at 10h00 using **Microsoft Teams**. Kindly join the **hearing 20 minutes before 10h00** in order for us to attend to all technicalities ahead of court, to ensure that we are ready to commence with court at 10h00.
3. In order for the court to consider the matter, parties should ensure that the pleadings, **Practice Note, Notice of Set down and Draft Court Order** are **uploaded onto Caselines**. The Draft Court Order should set out the **date of hearing, Judge's name** (i.e Acting Judge Meersingh), **the Number on which your matter appears on the roll** and the manner in which the **matter will be heard** (i.e Microsoft Teams), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft.
