1. Kindly note that the matters will be heard **IN OPEN COURT** before the Honourable HASSIM AJ in the week of 19 to 23 September 2022 and **ALL** Counsel are to appear unless their matters have been disposed of and/or dealt with timeously in terms paragraph 3 hereof.
2. The roll will be commence in the following manner. Postponements, removals and settlements may be called first as well as noting of appearances in opposed matters. Thereafter the roll will proceed in order of seniority and any opposed matters will be dealt with at the end of the roll.
3. In the event that a matter/s are to be removed or has become settled litigants need to inform the Judge's Chambers a minimum of 24 hours before the date of hearing by sending an email and uploading on Caseline. In the event that the Judge's Chamber is informed less than the 24 hours, an appearance will be required.
4. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives. Any uploading shall have been deems to have been completed once the Judge's Chambers receives



the roll save for matters falling in the category mentioned in paragraph 3 above.

5. Counsel must hand up at least two copies of draft orders already complete with the Judge's name (i.e., Acting Judge HASSIM), in which Court and, at the end of the draft order the party must indicate the name and contact details of both counsel and their instructing attorneys.
