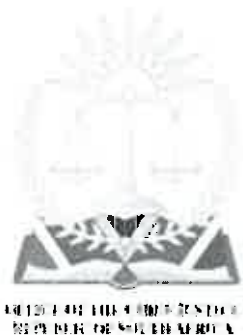

The unopposed motions will be done as follows:


1. Please be advised that it is not protocol to contact a Judge personally, either by way of an email or a phone call.
