- If documents are uploaded without permission the matter will be struck from the roll and costs will be disallowed.
- If a draft order is sought on the Caselines note, it is to be handed to the Judge in open court on the day of hearing.

- We will use courtroom **6E**
- All persons are to maintain a safe social distance.
- Court will start promptly at 10h00.

ORDERS:

- All draft orders handed up must contain the Judge's name, date and roll number.
