- 5. The Family Advocate's endorsement, if applicable, is to be uploaded onto CaseLines.**

9. The CaseLines bundle in respect of each matter will be frozen on Wednesday, 11 May 2022 at 16h00. Any document to be uploaded thereafter is to be done with the permission of Matsemela AJ.
