- [1] Kindly take note that all matters will be dealt with by way of Microsoft Teams commencing on Tuesday, 30 August 2022, at 10h00 for roll call where individual time slots will be allocated. - [2] If cases were not ready at time of filing at 12:00 on Thursday, 25 August 2022, (i.e. all relevant affidavits filed and the case indexed and paginated), they will not be heard, unless there is good cause or exceptional circumstances.

 - (f) Contact details of the legal practitioners, which must include both cellphone numbers and email addresses;
 - (g) Whether the matter can be decided on the papers or whether a video conference is required;
 - (h) If a hearing in open court is required, reasons must be stated.
- [5] Where no certificate of urgency has been filed and/or no practice note has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.
- In matters that are to be removed, postponed, unopposed or settled draft orders should be uploaded in both PDF and WORD format and are to be emailed to AThangavhuelelo@judiciary.org.za by no later than 16h00 on Monday, 29 August 2022. No hearing is required for these matters, unless

parties notify the Judge's Registrar otherwise.

[7] Draft orders should contain a disclaimer, indicating the date of hearing, Judges' names (i.e Collis J), manner of hearing (i.e Microsoft Teams) and the name and details of Counsel/Practitioner and those of the instructing attorney.
