  - (f) Whether the matter can be decided on the papers or whether a video conferenceis required;
  - (g) If a hearing in open court is required, the reasons must be stated.
- [3] Where no certificate of urgency has been filed and/or no practice note has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.
- In matters that are to be removed, postponed, unopposed or settled Mr Ndzukula must be informed telephonically and draft orders in WORD format are to be uploaded on caselines and emailed to Andzukula@judiciary.org.za by no later than 16h00 on Monday 14 February 2022.
