- 1. If cases were not ready at time of filing at 12:00 on Thursday 24 March 2022 (i.e. all relevant affidavits filed, the application indexed and paginated and a certificate of urgency and practice note filed), they will not be heard, unless there is good cause or exceptional circumstances.
- 2. No piece-meal filing of affidavits will be allowed.
