**Urgent Court Directive: Matters Before Judge Kooverjie (26 April – 3 May, 2024)**

**Court Venue: Court 4B**

**Important Notes:**

1. All matters will be heard publicly in Court 4B.
2. An allocated roll is attached. Attorneys only need to attend court on the day their matter is scheduled.
3. Hearings begin at **08:00 on Tuesday, 30 April 2024, in Court 4B**, starting with ex-parte applications and continuing until the roll is complete.
4. Hearings will resume at **09:00 on Thursday, 2 May 2024, in Court 4B**.
5. Proof of service for all matters must be uploaded to Caselines.
6. Practice Notes and Heads of Argument must already be on Caselines. If not, upload them by 16:00 on Friday, 26 April 2024.
7. Upload draft orders, heads of argument, and relevant authorities (if applicable) to Caselines.

**8. Due to recent technical issues:**

- Bring one copy of the order/draft order and any applicable heads of argument to court.
- If relying on specific authorities, bring physical copies of those as well. (Two copies of the order are needed if a court-signed order is desired.)

9. Court-issued orders will be uploaded to Caselines within a day (workload permitting).

10. No documents or orders should be emailed; use Caselines only.

11. Affidavits filed after 16:00 on Friday, 26 April 2024, may not be considered as the matter is not ready for hearing and should not have been placed on this urgent roll.

12. Attorneys must introduce themselves to the honourable madam Justice Kooverjie **outside** the courtroom before their hearing on the designated day. (You may wait inside court until Judge Kooverjie arrives.)

13. Please notify our office immediately if a matter needs to be removed from the roll or has been settled.
