**URGENT APPLICATIONS BEFORE THE HONOURABLE JUSTICE MBONGWE**

**02 – 05 APRIL 2024 IN OPEN COURT**

**DIRECTIVE**

1. There will be roll call in Court 4C on Tuesday, 02 April 2024 at 10:00.
2. Matters that are non-compliant with the Consolidated Practice directive will be struck from the roll, unless good cause is shown for such non-compliance.
3. Where matters are removed, a notice of removal must be uploaded onto Caselines and emailed to the presiding Judge's secretary as soon as possible.
4. It is the duty of the Applicant's attorney to ensure that no duplicate files are created on Caselines, and that bundles are fully uploaded by **14:00** on **Saturday, 30 March 2024**. No further documents may be filed without the Judge's specific written permission obtained by email. If documents are uploaded without permission the matter may be removed from the roll. If any problems are experienced, the Judge's Secretary must be contacted TIMEOUSLY.
5. In all matters a draft order in Word format is to be uploaded onto Caselines. Parties must bring one hardcopy of their draft order to court.
6. **No piecemeal filing of affidavits will be allowed.**

7. The Practice Note filed by the Applicant's attorney/ Counsel must set out the following:
- a. Particulars and contact details of the legal representatives;
  - b. Whether the matter is opposed;
  - c. Nature of the relief sought without referring to the Notice of Motion;
  - d. A brief summary of the factual and legal issues involved;
  - e. A brief summary on urgency, or the absence thereof;
  - f. The main issues to be considered;
  - g. A clear indication of which portion of the papers must be read and which should not;
  - h. Whether there has been service by the Sheriff and if not, the reasons thereof. (Service of process in all urgent applications shall comply with the Rules of Court. Where an agreement was reached by the parties to vary the requirements of the Rules to facilitate a wholly electronic exchange of papers, this must be specifically stated);
  - i. Estimated duration;

**Failure to file a Practice Note setting out all the above information, may result in the matter being struck from the roll.**
