## **DIRECTIVE: URGENT APPLICATIONS, 4 – 8 DECEMBER 2023**

- PLEASE TAKE NOTE that the Practice Directives dealing with urgent applications will be strictly applied. In this regard:
  - 1.1. Matters that were not ready at the close of the roll, that is 12h00 on Thursday 30 November 2023, and where the Judges Secretary has not been invited to CaseLines, such matters will be struck from the roll unless there is good cause or exceptional circumstances. Any problems encountered must be communicated to the Judges Secretary timeously.
  - 1.2. In all applications a Practice Note must be uploaded by no later than
    14:00 on Saturday 2 December 2023, setting out the following:
    - 1.2.1. The grounds of urgency;
    - 1.2.2. Nature of relief sought;
    - 1.2.3. Total number of pages;
    - 1.2.4. An indication which portion of the papers must be read;
    - 1.2.5. The estimate duration of the matter; and
    - 1.2.6. Contact details for the legal practitioners, which much include both cell phone numbers and email addresses.
  - 1.3. In all opposed applications, **Heads of Argument** by all parties must be uploaded by no later than **14:00 on Saturday 2 December 2023**.

- 1.4. A matter will be struck from the roll where parties have failed to file a Practice Note and (where applicable) Heads of Argument, unless there is good cause or exceptional circumstances.
- 1.5. Master Bundles must be properly indexed and paginated. Each document must be individually identified in the Master Bundle, including annexures. If not, the matter will be struck from the roll, unless there is good cause or exceptional circumstances.
- 1.6. Save with the leave of the Judge, no documents (save for the Practice Note and Heads of Argument) may be uploaded after 11h00 on Friday 1 December 2023.
- 2. All other matters will be heard in **open court, to be announced later**. It is not necessary for Legal Practitioners to introduce themselves to the Judge in chambers as they may do so when their matter is called in court.
- 3. Roll call will be held on Tuesday, 5 December 2023 at 10:00 and all the parties must attend and be ready to proceed with their matter on that day, although some matters may be allocated to later in the week.

\* If the parties are not in court at the end of roll call, their matters will be struck from the roll.

- 4. Two copies of the Order/Draft order, where applicable, should be available to be handed up in court.
- 5. Kindly inform the Judge's Secretary of any settlements or removals as soon as possible.
