DIRECTIVE FOR UNOPPOSED MOTIONS BEFORE JUDGE POTTERILL ON 16 AND 18 JANUARY 2024

1. The unopposed motion roll of Tuesday 16 January 2024 and Thursday 18 January 2024 will be called **physically in court and the hearing will begin strictly at 10:00**. Parties are to verify the court venue on the date of hearing.
2. All counsel are required to appear in all the applications and introductions are to take place at 09:45. You may attend to room 8.10, 8th floor for this purpose.]
3. Postponements and removals will be called first. Thereafter the applications will be called in order of seniority.
4. Legal representatives should ensure that all relevant documents are uploaded to CaseLines including the practice note, notice of set down and the draft order (in Word format) two court days prior to the hearing i.e. all documents in matters enrolled for 16 January 2024 to be uploaded by 16:00 on 12 January 2024 and all documents in matters enrolled for 18 January 2024 to be uploaded by 16:00 on 16 January 2024.

5. **Counsel are required to bring a hard copy of the draft order to court. Please ensure that the Judge's surname, date, case particulars and case number are correctly reflected on the draft order.**
6. The draft order which is uploaded must clearly reflect the surname of the Judge, date of hearing, manner of hearing, the name of the counsel, the attorney and their respective e-mail addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.

DISCLAIMER: This Order is made an Order of Court by the Judge whose name is reflected hereon, duly stamped by the Registrar of the Court and is submitted electronically to the parties or their legal representatives by e-mail. 7. All documents should be uploaded by 16:00 two court days before hearing as described in paragraph 4 above. If the documents are not in order, the matter will be removed from the roll. No late documents may be uploaded.
