DIRECTIVE: OPPOSED MOTIONS BEFORE RETIEF J (26-30 AUGUST 2024)

2. Matters will be heard at 10h00 in Open Court. Parties will be informed of the court room in due course.
3. The joint practice note in each matter must be uploaded onto Caselines **by 12h00 on Thursday, 22 August 2024** Counsel are requested to ensure that the joint practice note deals with all aspects identified in paragraph 25.17 of the Judge President's Consolidated Practice Directive 1 of 2024 and that the parties advise whether they are in agreement regarding the mode of hearing.
4. Please note:
 - 4.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, consideration of the compliance with the relevant directives pertaining to opposed motions will apply. **In particular matters which should be heard on the special motion roll due to duration must be removed, failing which the Judge may remove them having regard to the matter before her to be adjudicated.**
 - 4.2. Parties should ensure that proposed draft orders are uploaded in word format onto Caselines at least a day before a particular matter will be heard. Draft

orders should indicate the hearing date of the matter, the Judge's name, and the manner in which the matter will be heard (i.e. open court), and at the end of the draft order the names and details of all counsel/practitioners and of their instructing attorneys must be included.

4.3. In the event that matters are to be removed, postponed or become settled, the parties must communicate same via email with the necessary notices/draft orders without delay to ChMsimango@judiciary.org.za.

4.4. The parties are to ensure that the matters appear on caselines **by 12h00 on Thursday, 22 August 2024, failing which the matter will not be heard and removed.**
