1. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria. Introductions will be conducted at the **Palace of Justice chamber 148 at 09h40**.
2. In order for the court to consider the matter, parties should ensure that the pleadings, **Practice Note, Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**. The Draft Court Order should set out the **date of hearing, Judge's name** (i.e Judge Moshwana) and the manner in which the **matter will be heard** (i.e Court 6D), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft.

3. The Counsel/Attorney moving the application should bring **one copy of the Court Order** similar to the one **uploaded onto Caselines** for the Judge to sign if the Court is satisfied with the application.
4. Matters will be dealt with/called in a **numerical order**. Counsel/Practitioners should place their names on record and wait for the court to review their matters on Caselines.
5. The decorum of the court is to be maintained at all times.
