DIRECTIVE

1. **ALLOCATIONS AND INTRODUCTIONS**

- 1.1. The allocated Roll is distributed with this Directive.
- 1.2. All matters will be heard in open Court unless the presiding Judge directs otherwise.
- 1.3. Parties may check Court room allocations on the JSA Bar website: <https://www.johannesburgbar.co.za/court-rolls/>
- 1.4. The Unopposed Family Court Roll will be disposed of on Monday, *25 November 2024*, commencing at 10h00. Matters will be called by seniority.
- 1.5. The Opposed Family Court Roll will be in accordance with the allocations made and as published on the JSA website (see 1.3 above).
- 1.6. Unless otherwise indicated, Urgent applications will be heard on Tuesday, *26 November 2024*.
- 1.7. Introductions will be done by Counsel/Attorneys in open Court upon their matters being called on Record.

2. **ACCESSIBILITY**

- 2.1. In matters where it is noted on the Roll that there is no bundle created on CaseLines, there are therefore no documents before the Judge, and such matters will accordingly be removed from the Roll for non-compliance with the prevailing Practice Directives of this Division.
- 2.2. CaseLines Bundles are to be created in accordance with the prevailing Practice Directives of this Division and, without detracting from the generality of the foregoing, must include clearly demarcated Sections, with documents/annexures being properly identified and uploaded separately, and without there being any duplication. Non-compliance will result in matters being removed from the Roll.
- 2.3. No further documents may be uploaded onto CaseLines after **16h00** on Thursday, **21 November 2024**.

3. **PRACTICE NOTES, HEADS OF ARGUMENT AND DRAFT ORDERS**

- 3.1. Practice Notes (updated, and of a joint nature, where applicable) are to be uploaded to CaseLines by no later than **16h00** on Thursday, **21 November 2024**. The Practice Note is to contain the full particulars of Counsel and Attorneys, the nature of the application, the issues to be decided, indicating precisely where each may be found on CaseLines, and an estimate of the duration of the matter. If there is any other information to be conveyed, it must also be stated in the Practice Note.
- 3.2. Parties are to ensure that in all Opposed matters, Heads of Argument have been filed in accordance with the prevailing Practice Directives of this Division.
- 3.3. Draft Orders must be uploaded onto CaseLines by no later than **16h00** on Thursday, **21 November 2024**. Counsel must, in addition thereto, physically bring one hard copy to Court on the hearing date.
- 3.4. The Draft Order is to reflect the date, particulars of the presiding Judge, details of the Attorney of record, and of the Counsel/Attorney appearing.
- 3.5. The Orders which are brought to Court, **must** be “signature-ready” (i.e. please remove the word “Draft” from the tramlines, delete the “further and/or alternative relief” prayer etc).

3.6. Accordingly marked, signed and stamped Court Orders will duly be delivered using the platforms at the disposal of the respective parties.

4. **URGENT APPLICATIONS**

4.1. There must be strict compliance with the prevailing Practice Directives of this Division as applicable to urgent applications.

4.2. The allocation of a hearing date and time to an urgent application does not automatically translate into such application being regarded as urgent.
