3. All Matters will be heard in an open court.
4. The court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact the enrolment office.
5. No further documents may be uploaded on Caselines after 16:30 by Friday, 29 November 2024.
6. In matters where minor children are involved, both parties are advised to be present in court, in addition, viva voce evidence may be mandatory.
7. In matters where there are no children, and no evidence affidavit was uploaded by 16h00 29 November 2024 – viva voce evidence is required.
8. Introductions will be done in court and all proceedings are recorded.
9. Please **BRING a hardcopy** of a draft order to court and upload one on case lines.
10. Parties are reminded to ensure that the case number, roll number and parties names on the draft orders are correct as well as all annexures.
11. The general Family Court Directives are to be STRICTLY complied with.
12. Kindly ensure that it complies with the practice directive, i.e. the Judge's name, date, court room, etc. Including the below disclaimer:
