- (c) Only in exceptional circumstances, deemed by the Presiding Judge to aid in matters being expeditiously disposed of, and by prior arrangement with the Judge's Registrar, will a virtual hearing be alternatively resorted to.

## **(THE MUST-DO)**

### 2. Legal representatives are to ensure that:

- (a) a complete set of papers has accordingly been uploaded;
- (b) updated **Practice Notes** (*of a joint nature, where applicable*) is accordingly uploaded;
- (c) chronology is simultaneously filed with their Practice Note(s).
- (d) **Heads of Argument** are, in case of justiciable opposition, accordingly filed;
- (e) Draft Orders are accordingly uploaded. Furthermore, Counsel ought to present same in hard copy when moving for their sought and prayed-for order(s)

### 3. INACCESSIBILITY:

- Flagged matters 28/ #13 and 30/ #14 are inaccessible and, thus, liable to be struck out, unless just cause is shown as to why they should not.

### 4. INTRODUCTIONS:

- Unless there is, otherwise, anything pressing that the parties would like to bring to the attention of the Judge in chamber(s) or corridors (*especially in a case where a matter is to be heard openly*), **COUNSEL WILL INTRODUCE THEMSELVES IN COURT** upon their matters being called on record.
