- 3. Authority bundles should be uploaded on the case file on CaseLines by no later than 16:00 on Monday, 13 JANUARY 2025. **Counsel are expected to hand a bundle of their authorities on the day of the hearing.**
- 4. Draft orders should be uploaded onto Caselines in Word format with the names of the

parties and the number on the roll. The draft order should identify the judge as “MATSEMELA AJ”.

5. In matters where there has been non-compliance with the consolidated Practice Manual or Practice Directive 1 of 2024 the matter is at risk of being removed from the roll.
6. If it is not necessary for the judge to read the papers in a matter, the judge’s secretary should be informed as soon as possible, alternatively, a widely shared note should be entered onto caselines indicating same.
